TASK #1a:

Scope of Service:

Create a prioritization of projects in list and description format. Construction projects to have ability to substantially complete for less than \$50,000 each and support the development of the airport. Projects include road extensions, water and sewer main extensions and improvements, electrical and dry utility line extensions, and additional survey services. Consultant will align the projects with the Capital Improvement Program. The format will include an exhibit of the north-end expansion area and an exhibit of the south- end expansion area identifying projects with number format. A spreadsheet of the projects will be provided and maintained in excel format with prioritization recommendation. Conceptual costs will be used in this analysis with anticipation of of 10-20 projects can be funded in the foreseeable future with combined costs of \$250,000 to \$500,000. 4) provides public education relating to the agency's complaint process;

5) requires appropriate corrective action to be taken against a peace officer employed by the <u>GILLESPIE CO.</u> <u>CONST. PCT. 2</u> who, after an investigation, is shown to have engaged in racial profiling in violation of the <u>GILLESPIE CO. CONST. PCT. 2</u> policy;

6) requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:

a. the race or ethnicity of the individual detained;

b. whether a search was conducted and, if so, whether the individual detained consented to the search;

c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;

d. whether the peace officer used physical force that resulted in bodily injury during the stop;

e. the location of the stop;

f. the reason for the stop.

7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision (6) to:

a. the Commission on Law Enforcement; and

b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.

(c), Code of Criminal Procedure during the reporting period.

GILLESPIE COUNTY ENGINEERING DEPARTMENT TEMPORARY CONSTRUCTION ACCESS AGREEMENT

This Temporary Construction Access Agreement ("Agreement") is entered into this <u>6</u> day of <u>March</u>, 2024 by the Hill Country Community Needs Council ("Developer"), and Gillespie County ("County").

The County hereby grants the Developer access to 95 Frederick Road (PID 61671), owned by Gillespie County, ("Property") as a temporary construction access to facilitate the construction of the HCCNC Child Development Center at 1904 N Llano Street ("Project") after periods of inclement weather to avoid damage to the drainage channel running along the Project's west property line. The limits of the access boundaries are described in Exhibit A.

This Agreement is granted in accordance with, and subject to, the following terms, conditions, requirements, and limitations:

- 1. Access is granted for vehicular and pedestrian traffic relating to the construction of the Project when written request for access is provided to the Precinct Commissioner 24 hours in advance of any such need for access.
- 2. There shall be no stockpiling, staging, or storage of construction materials, soil, equipment, or vehicles on the Property. The Contractor shall keep the Property and other adjacent areas free from accumulations of waste materials and other debris.
- 3. In no event may any use of the Property by the Developer and its contractors, subcontractors, suppliers, workers, successors, agents, and assigns thereof violate any applicable law, rule or regulation relating to the Property or impact daily operations on the Property. The Developer assumes all risk of damage to property or injury to persons, in or upon the Property arising from this Agreement.
- 4. The term of this Agreement shall begin upon the date of mutual execution and shall extend until January 1, 2025 or until the Project has been completed, whichever first occurs. The Developer may request an extension to the Agreement by giving written notice of the request to the County at least 7 days prior to expiration.
- 5. Before expiration of the Agreement, the Developer, at its sole cost and expense, shall restore the Property to the same condition it was in prior to the Developer's use.
- 6. The Developer agrees that in the event the terms of this Agreement are violated, that such violation shall immediately be corrected by the Developer at Developer's sole expense upon receipt of written notice from the County.
