2. Consider approval of the Fiscal Year 2025-26 budget for Gillespie County (must be record vote).
3. Consider ratification of any property tax increase reflected in the Fiscal Year 2025-26 budget for Gillespie County.
4. Consider approval of the County tax rates for Maintenance & Operations (M&O) and Interest & Sinking (I&S) for Tax Year 2025 (must be record vote).




