As of January 1, 2007, Gillespie County started collecting a lodging occupancy tax in the areas of Gillespie County which are outside the City of Fredericksburg and its extraterritorial jurisdiction (ETJ). The collection of this occupancy tax was authorized by House Bill 214 which was approved by the State Legislature in 2005 ... Updated in 82nd Legislative Regular Session with HB1234 in 2011.

The amount of tax that you as a lodging operator should collect from your guests on behalf of <u>Gillespie County is 7%</u>. This is in addition to the 6% tax that you collect for the State. Please note, however, that if you are collecting the 7% occupancy tax for the <u>City of Fredericksburg</u>, then the County's occupancy tax <u>DOES NOT APPLY</u> to you. Guests who stay in any lodging facility in Gillespie County will be subject to an occupancy tax in the total amount of 13%.
