Youth Crisis Respite Center The Youth Crisis Respite Center provides short-term, residential crisis services to youth ages 13 to 17 who are experiencing a mental health crisis and who are at low risk of harm to self or others. The center is in a traditional home environment with 24 hour supervision providing individualized services targeted to alleviate the current identified crisis. The project will integrate primary care services into the Hays County Mental Health clinic as a means to address integrating primary and behavioral health care for individuals with severe and persistent mental illness. Individuals can receive both their psychiatric and physical health care from the same clinic thus avoiding potentially preventable admissions to hospitals and reduce emergency department utilization. The goal is to provide integrated care to individuals with co-occurring issues using a person-centered and whole health approach. MCOT (Kerr/Val Verde/ Kinney Countles) The Mobile Crisis Outreach Team (MCOT) is designed to respond in the community to assist individuals in a mental health crisis. Individuals are served where they are-(community settings). MCOT provides a combination of crisis services including assessment, service coordination, crisis follow-up and relapse prevention to both children and adults. MH Court (Hays, Comal, Uvalde, and Medina Counties) Mental Health Court (MHC) is a three-part program for adults who have been charged with one or more misdemeanor offenses or a qualifying felony offense and who are having difficulty with mental health issues. The MHC uses a non-adversarial approach involving prosecutors and defense attorneys to promote public safety and to protect the due process rights of program participants. It is a joint effort of Misdemeanor / District Court, Department of Community Resources, District Attorney's Office, Probation Department, Pre-trial Services, and Hill Country MHDD. By working together, the team provides an individualized treatment plan to help individuals develop stability in their lives, promote self-sufficiency and to return them to the community as a productive and responsible citizens.
